

Regular Meeting
July 17, 2017

The regular meeting of the Pelican Town Hall was called to order by Chairman: Bruce Galles, Present: Supervisors: Bruce Galles, Robert Olson, Bruce Westerberg, Treasurer: Jody Wallin, Clerk: Shirley Wallin. Also present: Roy Zillmer, Tony Loberg.

The Pledge of Allegiance was said by all.

Police Report: none

Olson made a motion to correct an error in minutes to say no one will drive on their driveway. Olson made a motion to approve minutes as amended, seconded by Galles, motion carried.

Treasurer's Report: given by Jody Wallin: Opening Balance: \$118,046.49, Receipts: \$116,523.84, Disbursements: \$30,670.93, Balance: \$203,899.40, Frandsen Bank: \$203,899.40, Investments: BlackRidge Bank: \$219,012.15, Interest: \$99.01, Total Investments: \$219,111.16, Total Funds & Investments: \$423,010.56. Olson made a motion to approve Treasurer's report, seconded by Galles, motion carried. We did receive a settlement from the County at the beginning of July and that included payments from West Cree Bay Circle residents, received \$15,191.67. Jody will check with the County as there were some odd amounts received on various properties.

Bills to be paid were presented. Olson made a motion to pay all bills, seconded by Galles, motion carried.
