ROAD REPORT: Road Maintenance man has done some brushing, seal cracking. Loberg asked if he could get a leaf blower for opening cracks to seal. Galles will loan one to see if that is powerful enough. Loberg would also like to spray round-up around guard rails, as he can't get to it with the mower.

ZONING: James & Melanie Weaver want to rezone 5.25 acres from Ag to SR1, Donovan made a motion that we recommend SR2 instead of SR1 because of the density of shoreline, motion died due to lack of second. Discussion held. Donovan made a motion of no objection, seconded by Olson, motion carried.

OLD BUSINESS: Donovan went over some calculations for fire costs with Mission, discussion held. Donovan will check with Pequot Lakes Fire Dept. to see if they will cover parts of Mission and the cost. Galles will speak with Nisswa Fire Chief. Clerk will call Auditor to get tax capacity for all 3 Fire Dept.

NEW BUSINESS: CD at Lakewood Bank will be coming due on April 20th the new rate for 12 months will be 1.70%, Rockwell will roll over the CD, Galles will make a call to Lakewood Bank to see if he can get a better rate.
