Olson made a motion to approve Treasurers report, seconded by Donovan, motion carried.

Bills to be paid were reviewed, Olson made a motion to pay all bills, seconded by Donovan, motion carried.

Public Forum: Roy Zillmer was present from W. Cree Bay, the township needs some financial guarantees from the residents, need to get a list from county of W. Cree Bay residents, they need to pay upfront costs for list, mailings, engineering estimates, etc. Roy will talk to the residents and bring to next meeting.

Received a card from A&H Company, Inc. for signs and posts. David Bauer from brokerage firm Murphy Business of MN, LLC, if we considered selling a business to consider them. Road Report: Loberg said the roads are in good shape for the spring, they have been doing crack sealing and he introduced Marco Arriago to the board and he has been helping Loberg with the sealing of the cracks.
