

Regular Meeting

The regular meeting of the Pelican Town Hall was called to order by Chairman Bruce Galles, Present: Supervisors: Bruce Galles, Robert Olson and Tracy Donovan, Treasurer: Jody Wallin, Clerk: Shirley Wallin. Also present: Bruce Westerberg, Jason Rieber from BPPD.

Correspondence: Received Mission Fire Report, 1 call dispatched and cancelled in route. Received 3 letters back from W Cree Bay Landowners, Clerk has re-mailed 2, received 1 back today (date of meeting). Clerk has no forwarding address, Clerk received correct address from Roy Zillmer. Received assessment notice from Crow Wing Co. Abstract Co. in Crosslake for Sienna World Golf, they list it as E Cree Bay Circle in Breezy Point but it is on the W. Cree Bay Circle as the property ID #'s is the same as on W. Cree Bay Circle. Returned notice with assessment amount for each lot. We received letter from Crow Wing Land Service Dept. stating there are 2 plots to go into tax forfeited to sell, we do not need to respond if we have no objections. Board does not object. We received tax court filing for 2017 payable year for David Williams.

Board recessed the meeting to conduct a meeting with W. Cree Bay landowners at 7:30 PM, to go over assessments they will be each billed on taxes or can pay before it goes on taxes. Meeting reconvened at 8:18 PM.

Road Report: Loberg said that the sand pile and plow blade is blocked in by contractor equipment to repair roof and town hall building, Galles will call contractor to have them move it. Loberg still has some patching and edging to do. Loberg will order some signs to go on W Cree Bay Circle for 25 mile hr. speed and 2 no outlet signs.
