Road Report -

Tony: Drove the roads to set up summer work – roads are in pretty good shape. Beaver Dam edging repaired with black dirt and seed. Working on maintaining our equipment to keep it looking and operating ideally – it is all doing well. Seal cracking is challenging as harder to do alone, everything is prepped so as able it is getting done. Westerberg mentioned that Pelican Way has a sink hole – Tony will go check it out and see what can be done. Polymastic on Wallin's South Shore is holding up very well.

Committee Reports – Pequot Fire meeting May 13, 2020 – Westerberg is attending. Trying to understand how they calculate the fireman's relief

Zoning Issues – Foote variance request – Public Hearing being held May 21 – we need to respond. Discussion held – site visit conducted 5/7/2020, Westerberg attended. Variance Board Member discussed how far back for side yard set backs, lot 114 –next lot – is wetland and will require DNR to be

buildable. He recommended they come in with existing plan and negotiate at the meeting. Lake Setback is currently on 39'. Tax value with mobile home on it is currently \$149,000. Supervisors made a motion to voice "Our concern is distance from the lake to building need to be adjusted. Numerous other set back issues also is a concern." Supervisor, Bruce Galles made the motion, Supervisor Bruce Westerberg seconded, Vote was taken – passed 2-1. Morris only descending vote – his concern being voiced as being unfair to those who have followed the rules and built without a variance.

New, Old, Other Business – County Road 4 equipment and driveway complaint – Westerberg went and talked to him and everything is ok now.

*Samantha is getting married and moving out of township, will need to resign after June meeting. Alisha Wallin is interested in the position – ok to train her? Yes.
