

October 2020 Regular Meeting Minutes

10/13/2020 –7:30 pm – Galles called meeting to order. Pledge of allegiance was said by all

Police Report – no one present – written report only

Public Forum – Bruce Jones – regarding issues on Cullen Channel Lane

1. Road condition of culvert – it is a bog, we have surveyed the land owners informally in the past and they have wanted us to leave it alone. If we were to do anything to that road – the biggest issue: how do we get access for the residents while work is being done as it is a multi-day project? Bruce Jones did offer Wilderness Road
2. Public Access occasionally can get so busy you can hardly pass thru the road – no parking on the North side of the road – we do have the authority to do so and will do so
3. Speed Limit on Sunset Valley does not match, north bound vs south bound – Tony will move them so they match based on the speed study guidelines
4. Upper Cullen Rod/Cullen Chanel speed – how low can we post it? Rural Residential, can do 35 for sure. Thinking 25 is an option. We will contact County Highway Department to confirm and then can do a resolution at next meeting.

Westerberg made motion to put no parking signs on North side of the road by the public access as well as move the speed limit signs on Sunset Valley to be matching start/stop where the speed study allowed. Morris Seconded; none opposed, motion passed unanimously.
