# **Road Report** -

\**Tony* – We are ready for winter. Equipment has been gone through still shouldering as weather allows.

\*<u>Pelican Beach Road Speed Limit-</u>Radtke will ask MAT to clarify verbiage. Breezy Point Police Department has seen the curve markings with cautionary speeds to be somewhat effective, pursuing the legal information is a lot of work and reviewing which could turn out to not really help at all. Morris suggested the board look at the catalog for signage – Tony gets the signs from M & R signs out of Fergus Falls, same place as county.

<u>OSHA Chainsaw Rules</u> – Tony looked at equipment and looks like it could be 600-800. Morris will contact MAT to determine what is required and for what work.
