Police Protection Review: Contract includes 20 hours a week, virtually 24 hour EMT response, increase of 1500.00 will be \$52,000.00 for this coming year. 50 years as a Police Department 1969, 1st full time officer, John Miller. To Celebrate 50 years commemorative coin commissioned and for sale for \$10.

Polymastic Testing done on Shelstad Lane Last Year. Redid Pelican Beach Road one of our oldest roads. Plan to do a combination of things to Sunset Valley this year seal coating as a test again, mill and overlay because necessary on a stretch and then overlay on another stretch. We have a plan to work on our roads slowly so they don't all need to be redone at once.
